- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. The *Get Creative, Get a Prize* Contest ("Contest") is organized by Explain Everything sp. z o. o. ("Organizer"), a limited liability company based in Poland.
- 2. Eligibility: The Contest is open to legal residents of all states over the age eighteen (18), and is void where prohibited by law. You should not send a video through the email, only via proper link. One person can send only one competition project. Entries will be accepted starting on Monday, August 2nd, 2021 and ending on Tuesday, August 10th, 2021.

Whiteboard projects must not contain:

- adult content, including nudity, depictions of people in explicit or suggestive positions, or activities that are overly suggestive or sexually provocative;
- shocking, sensational, disrespectful or excessively violent content;
- deceptive, false, or misleading content, including deceptive claims, offers, or business practices.

Organizer reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions.

- 5. **Judging:** The judging period begins on August 11th, 2021 and ends on August 16th, 2021. A panel of judges ("Judges") selected by the Organizer, in its sole discretion, will judge the entrants and select a Prize Winner based on the following criteria:
 - creativity and originality
 - the best use of tools of Explain Everything application
 - aesthetics and visual effects
